A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AGREEMENT WITH FC-7096-99A, WRECKER SERVICES FOR VEHICLES OVER (2) TONS WITH SOUTHERN TOWING SERVICES, INC., FOR ZONES 3, 4, 6 AND 7; ALL WORK FOR SAID CONTRACTS SHALL BE PAID TO FUND, ACCOUNT AND CENTER NUMBER: TOWING 1A01 462316 B00001, SALES OVERAGES: 1A01 469101 B0001.

WHEREAS, The Chief of the Atlanta Police Department and the Purchasing Agent of Purchasing and Real Estate solicited a Request for Proposals for FC-7096-99A, Wrecker Services for vehicles Over 2 Tons, and

WHEREAS, the potential for multiple awards was made a part of the solicitation and the Department of Police recommended approval of two contractors for towing of vehicles over two (2) tons; one for zones 1,2, and 5, and the other for Zones 3, 4, 6 and 7; and

WHEREAS, the contracts generate revenues from fees charged per tow and from sales overages associated with the sale of vehicles at auctions held by the wrecker service companies.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor be and is hereby authorized to enter into appropriate contractual agreement for FC-7096-99A, Wrecker Services for Vehicles over 2 Tons with Southern Towing Services, Inc., for a period of one year with an option to renew for two additional one year periods.

BE IT FURTHER RESOLVED, that the Director of the Bureau of Purchasing and Real Estate be and is hereby directed to prepare an appropriate contract for execution by the Mayor, to be approved by the City Attorney as to form.

BE IT FURTHER RESOLVED, that said contract shall not become binding on the City and the City shall incur no liability upon such contract until the contract has been executed by the Mayor and delivered to the contracting parties.

BE IT FINALLY RESOLVED, that all work for said contracts shall be paid to Fund, Account and Center Number: Towing 1A01 462316 B00001, Sales overages: 1A01 469101 B00001.
