WHEREAS, the City of Atlanta did solicit bids for FC7505-02; Demolition Services Runway 10/28 – Land Acquisition, Phase II; and

WHEREAS, the General Manager of the Department of Aviation and the Director of the Bureau of Purchasing and Real Estate have recommended that contract, FC-7505-02, Demolition Services for Runway 10/28 Land Acquisition Phase II, be awarded to the lowest, most responsible and most responsive bidder, Nile Inc.; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor be and is hereby authorized to enter into an appropriate contractual agreement with Nile Inc, in an amount not to exceed \$1,209,789.00.

BE IT FURTHER RESOLVED, that the Director of the Bureau of Purchasing and Real Estate be and is hereby directed to prepare an appropriate Contract for execution by the Mayor, to be approved by the City Attorney as to form.

BE IT FURTHER RESOLVED, that this agreement shall not become binding on the City and the City shall incur no liability upon same until such Contract has been executed by the Mayor and delivered to contracting parties.

BE IT FINALLY BE RESOLVED, that all contracted work shall be charged to and paid for from Fund Account and Center Number 2H26 571001 R21E052096AA.
