A RESOLUTION URGING THE ELIMINATION OF PRICE GOUGING FOR PARKING FEES DURING SPECIAL EVENTS, CONVENTIONS, ETC. AND FOR OTHER PURPOSES

WHEREAS, the City of Atlanta is host to numerous special events, conventions, etc. every year, and

WHEREAS, parking space for vehicles is in moderate supply and great demand near various venues in the City; and

WHEREAS, it is incumbent upon parking companies to offer fair and reasonably priced fees to patrons who seek to park near high volume venues; and

WHEREAS, the practice of price gouging is inappropriate and contrary to the principles of positive hospitality in the City of Atlanta; and

WHEREAS, the hospitality industry is a vital component of the economic engine in the City of Atlanta; creating jobs, revenue for businesses and revenue for governmental entities; and

WHEREAS, price gouging for parking fees could detract from Atlanta's ability to compete with other comparable cities and attract national and international events.

NOW THEREFORE THE ATLANTA CITY COUNCIL HEREBY RESOLVES that the parking industry is urged to eliminate price gouging for parking during special events and conventions in the City of Atlanta.

BE IT FURTHER RESOLVED that parking industry is requested to limit the increase during special events, conventions, etc. to an amount not to exceed 100% of the regular price for parking.

BE IT FINALLY RESOLVED that a copy of this resolution be forwarded to members of the Atlanta parking industry, the Metropolitan Chamber of Commerce, The Atlanta Convention and Visitors Bureau, and major venues inside the City of Atlanta.
