

AN ORDINANCE

Finance/Executive Committee

An Ordinance to amend Article IV, Section 114-414 of the Code of Ordinances of the City of Atlanta so as to authorize the granting of two (2) personal leave days for employees of the City of Atlanta; and for other purposes

WHEREAS, during the last several years, the salaries of the employees of the City of Atlanta have not kept pace with inflation; and

WHEREAS, it is the desire of the governing body to compensate employees in some manner that would be budget neutral; and

WHEREAS, granting of additional leave days would accomplish this purpose.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA as follows:

Section 1: That Section 114-414 **Holidays** be amended to add a new subsection, to read:

(g) All permanent employees of the City of Atlanta shall be granted two (2) personal leave days. One such day shall be taken during the first half of the calendar year (January – June) and the second day shall be taken during the last half of the calendar year (July – December). The request for such leave shall be submitted to the employee's immediate supervisor on a form designated by the department. Such leave may be taken only after approval by the appropriate department or bureau head. Such leave shall be scheduled in accordance with the needs of the respective department.

Section 2: That all ordinances and parts of ordinances in conflict herewith are hereby waived.
