



**AN AMENDED ORDINANCE
BY TRANSPORTATION COMMITTEE**

**AN ORDINANCE AUTHORIZING THE FIRST AMENDMENT TO THE
MARCH 16, 2000 INTERGOVERNMENTAL AGREEMENT BETWEEN
CLAYTON COUNTY, GEORGIA AND THE CITY OF ATLANTA; AND
FOR OTHER PURPOSES.**

WHEREAS, the City of Atlanta (hereinafter "the City") owns and operates William B. Hartsfield Atlanta International Airport (hereinafter "the Airport"); and

WHEREAS, the Airport is undergoing a major expansion, including the construction of a new runway and taxiway and other facilities and improvements; and

WHEREAS, to accomplish said expansion, the City needed and continues to need to acquire properties lying within the unincorporated portions of Clayton County (hereinafter "the County") including but not limited to private property, public property, public streets, public rights of way, and certain easements held by the County; and

WHEREAS, the City and County entered into an Intergovernmental Agreement with each other dated March 16, 2000 (hereinafter "the Agreement"), in which the City and County set forth their mutually satisfactory understanding regarding issues pertaining to the Airport expansion, including but not limited to the City's ability to condemn property in specific areas located within unincorporated Clayton County; and

WHEREAS, the City needs to acquire properties that are located in unincorporated Clayton County, but are not set forth in the Agreement, to accommodate the Airport expansion; and

WHEREAS, the County wishes to receive assurances from the City regarding the opening of relocated Sullivan Road to two-way traffic, and regarding the City's granting of an easement to the County to accommodate the anticipated relocated Clark Howell Highway.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor be and is hereby authorized to enter into a First Amendment to the Agreement, on behalf of the City, whereby Clayton County shall consent to the City's acquiring by condemnation and, if County-owned, shall convey to the City by deed, all of the property located in the hatched area of Exhibit 1 hereto, whereby the City shall agree to use its best efforts to open the relocated Sullivan Road for two-way traffic by December 1, 2003, and whereby the City shall set forth its intention to provide an easement to the County to accommodate the relocated Clark Howell Highway, the approximate location of the easement being set forth in the hatched area of Exhibit 2 hereto.

BE IT FURTHER ORDAINED, that the City Attorney be and is hereby directed to prepare the amendment for execution by the Mayor, to be approved by the City Attorney as to form.

BE IT FINALLY ORDAINED, that this amendment shall not become binding on the City and the City shall incur no liability upon same until such amendment has been executed by the Mayor and delivered to Clayton County.


