AN ORDINANCE AMENDING THE 2003 (COMMUNITY DEVELOPMENT FUND) BY ANTICIPATING AND APPROPRIATING \$266,372.00, 2003 (HOME INVESTMENT FUND) BY ANTICIPATING AND APPROPRIATING \$137,000.00, AND 2003 (INTERGOVERNMENTAL GRANT FUND) BUDGET BY ANTICIPATING AND APPROPRIATING \$116,520.00 AND TRANSFERRING APPROPRIATIONS FROM RESERVE ACCOUNTS TO ADMINISTRATIVE ACCOUNTS IN THE 2003 CDBG, HOME, AND HOPWA PROGRAMS; AND FOR OTHER PURPOSES.

WHEREAS, the City Council adopted on November 4, 2002 and the Mayor approved on November 8, 2002, projects and program administration to be included in the 2003 Community Development Block Grant (CDBG), 2003 Home Investment Partnership Grant (HOME), and 2003 Housing Opportunities for Persons with AIDS (HOPWA) Programs; and

WHEREAS, the administrative projects included in the 2003 CDBG program are:

CD-03-07, Housing Rehabilitation Administration
CD-03-55, Housing Code Inspection

WHEREAS, the Budget Commission of the City of Atlanta has recommended increasing estimated receipts in the 2003 (Community Development Fund) Budget by \$266,372.00, the 2003 (HOME Investment Trust Fund) Budget by \$137,000.00, and in the 2003 (Intergovernmental Grant Fund) Budget by \$116,520.00.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:
