SECTION 1. That the 2003 Comprehensive Development Plan (CDP) of the City of Atlanta, Georgia is hereby amended by changing the Land Use Element of said Plan so as to re-designate property that is located at **The Perry Homes Redevelopment Area**, from the "*Medium Density Residential*" land use designation to the "*Mixed Use*" land use designation, and for other purposes.

All that tract or parcels of land lying and being in *Land Lots 224, 225, 226, 227, 228 and 247 of the 17th District of Fulton County, Georgia*. Said property is more specifically shown on the attached map, Exhibit 'A', which is hereby made a part of this ordinance.


SECTION 2. That all ordinances or parts of ordinances that are in conflict with this ordinance are hereby repealed.


