**RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO VARIOUS
CONTRACTUAL AGREEMENTS FOR THE IMPLEMENTATION OF PROJECTS UNDER
THE 2003 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG), AND THE 2003
HOUSING OPPORTUNITIES FOR PERSONS WITH AIDS (HOPWA) PROGRAMS; AND
FOR OTHER PURPOSES**

WHEREAS, projects were approved in the 2003 Annual Action Plan for the CDBG and HOPWA programs and these projects are ready for implementation; and

WHEREAS, the City has obtained release of funds from the U.S. Department of Housing and Urban Development (HUD) for these projects, based on the filing of environmental clearances.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:
