

Kevin Perry is the Executive Director for the Georgia Soft Drink Association in Atlanta, Georgia. Kevin is responsible for maintaining the soft drink industry's internal and external communications programs, and also works to promote good relations with GSDA members, governmental officials, business organizations, local and state news media, and community organizations. As Executive Director, Kevin serves in three primary capacities: soft drink industry lobbyist, public relations strategist, and association manager.

In addition to his role with the soft drink industry, Kevin serves as President of the Georgia Recycling Coalition; Board Member of the Keep Georgia Beautiful Foundation; Founder and Board Member of Georgians for Comprehensive Recycling; and, Board Member of the State YMCA of Georgia. Active in the Government Affairs Council of the Georgia Chamber of Commerce, Kevin further promotes sound public policy as a member of the Metro Atlanta Chamber and the Georgia Public Policy Foundation.

Prior to joining GSDA, Kevin was Manager of State and Local Affairs for the National Soft Drink Association in Washington, D.C. Kevin's accomplishments at NSDA include executing the industry's grassroots program, defeating forced deposit and special tax proposals in several states, and developing resources for state associations and industry government affairs representatives.

Kevin also has worked as a legislative aide and campaign assistant for former Georgia Congressman George (Buddy) Darden. In addition to his federal experience, Kevin served as a session aide at Georgia's statehouse for Lieutenant Governor Pierre Howard.
