AN ORDINANCE TO AMEND SECTION 30-1405 BY  
ABOLISHING THE TWO CURRENT PUBLIC STREET  
VENDING LOCATIONS AND CREATE TWO NEW PUBLIC  
STREET VENDING LOCATIONS IN THE DOWNTOWN  
AREA; AND FOR OTHER PURPOSES.

WHEREAS, the two (2) public vending locations on Peachtree Street in the Downtown Area in the City of Atlanta are creating public safety issues for pedestrians and motorist; and

WHEREAS, it is appropriate for the City to abolish these two (2) public vending locations on Peachtree Street to prevent any public safety issues; and

WHEREAS, it is desirous for the City to find appropriate replacement sites within close proximity of the displaced vending locations; and

WHEREAS, it is would be beneficial to the citizens, visitors and the vendors to create the two (2) new vendor locations in the Downtown Corridor.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF  
ATLANTA, GEORGIA as follows:

**SECTION 1:** That Section 30-1405 subparagraph (a) (5) d. Locations 5-13 and 5-14. The east side of Peachtree Street from Ellis Street, south 100 yards (two locations) is hereby deleted.

**SECTION 2:** That a new Section 30-1405 subparagraph (a) (5) d. shall be inserted to read as follows: Locations 5-13 and 5-14. The east side of Peachtree Street between Wall Street and Decatur.

**SECTION 3:** That all ordinances and parts of ordinances in conflict herewith are hereby repealed.
