AMENDING CHAPTER 110, PARKS AND RECREATION OF THE CODE OF ORDINANCES, ARTICLE I, SECTION 110.3, FEE SCHEDULE, SUBSECTION (d)(1), SPECIFICALLY TO REFLECT INCLUSION OF INCREASED WEEKEND FEES AND INCLUSION OF ANNUAL MEMBERSHIP FEES FOR CANDLER PARK GOLF COURSE; AND FOR OTHER PURPOSES.

WHEREAS, the Department of Parks and Recreation operates the Candler Park Golf Course; and

WHEREAS, the Candler Park Golf Course is a nine-hole golf course on which play is limited to walkers only, with no opportunity to rent carts; and

WHEREAS, many patrons, mostly nearby residents and older individuals, play Candler Park Golf Course on a regular basis for exercise; and

WHEREAS, as recently as last year, Candler Park Golf Course offered annual memberships; and

WHEREAS, nearby residents and older individuals (totaling fewer than 50 individuals) took advantage of the ability to purchase annual membership passes; and

WHEREAS, the annual period of many of these passes is now expiring, and Candler Park Golf Course is losing players; and


WHEREAS, the other four City-owned golf courses are operated by American Golf Courses; and

WHEREAS, American Golf Courses provides the opportunity for patrons to purchase annual membership passes which allow members to play any of the four eighteen-hole golf courses operated by American Golf Courses; and

WHEREAS, the fees established for 2003 provided new rates for daily play on weekdays but left unchanged the fees for daily play on weekends which has resulted in play being more expensive on weekdays than weekends.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: That Section 110.3(d)(1) Candler Park Golf Course fees be and is hereby amended by increasing Weekends (Friday—Sunday): Residents fee to \$9.00; Students and Senior Residents fee to \$7.00; Non-Residents fee to \$11.00; and Non-Resident



Seniors and Students fee to \$8.00; and to provide the following Annual Membership Fees (Not valid on weekends or holidays before 12:00 noon): Residents \$400; Resident Students and Seniors \$325; Non-Residents \$550; Non-Resident Students and Seniors \$475.

Section 2: That all ordinances and parts of ordinances in conflict herewith are hereby repealed.
