

WHEREAS, the Atlanta City Council allocated the necessary funding to reinstate the salary increment for fiscal year 2003.


**NOW BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA,



AN ORDINANCE TO AMEND THE 2003 BUDGET SO AS TO RESTORE THE SALARY INCREMENTS FOR ALL CITY OF ATLANTA EMPLOYEES; AND FOR OTHER PURPOSES. 03-0 -0107

WHEREAS, the 2002 City of Atlanta's adopted budget required that employees made certain concessions; and

WHEREAS, one of those concessions was that employees were to forego salary increments; and

WHEREAS, the City of Atlanta ended the year 2002 with a budget surplus; and

WHEREAS, it is appropriate and it should be a priority of the City of Atlanta to restore salary increments; and


WHEREAS, the Atlanta City Council is desirous of re-instating these increments in an effort to improve the morale of city employees.

NOW BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That the salary increments for all city employees shall be fully restored, retroactive to the first pay period in 2003.

SECTION 2: That the 2003 budget shall be amended accordingly so to appropriate the necessary funds in the amount of \$4.2 million to pay for the cost of salary increments.

SECTION 3: That all ordinances or parts of ordinances in conflict herewith are hereby rescinded.
