Cathy: Greetings.

The President of City Council gets one discretionary appointment to our Board of Directors. That appointee serves at pleasure of the the president or up to a four year term. **Lisa Borders, Senior Vice President Cousins Properties** was appointed to our Board of Directors by you in May of 2001 to fill the unexpired term of a resigning board member representing Cousins Properties. Ms. Border's term is up on **May 27th of this year**. Lisa represents a major property owner in Buckhead and has been strong contributing member of our board of directors.
