**A RESOLUTION TO SUPPORT THE MAYOR IN  
THE ESTABLISHMENT OF A TASK FORCE TO  
CONVENE ON THE PROPOSED AMENDED LIVING  
WAGE ORDINANCE #03-O-0409 AND REPORT  
THEIR FINDINGS AND RECOMMENDATIONS TO  
THE MEMBERS OF THE ATLANTA CITY COUNCIL  
WITHIN 90 DAYS; AND FOR OTHER PURPOSES.**

**WHEREAS**, Legislation #03-O-0409 was introduced and has been the subject of several ongoing Work Sessions and Public Hearings by the Finance/Executive Committee; and

**WHEREAS**, this Ordinance proposes to amend the Code of Ordinances of the City of Atlanta to add a new article to ensure that the City of Atlanta and businesses that benefit from receipt of City funds or from use of City property engage in responsible business practices by paying their employees a living wage and health benefits; and

**WHEREAS**, the Mayor and the Council desires to more thoroughly examine the issue of a Living Wage and agrees that this can be done thru the combined efforts of a Taskforce; and

**WHEREAS**, the Council supports the Mayor in the establishment of and appointment of persons to serve on the Task Force.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA**, that:

**SECTION 1:** The Task Force shall submit their written findings and recommendations to the Mayor and Council within 90 days following adoption of this Resolution.

**SECTION 2:** That The Task Force shall consist of at least seven (7) members.

**SECTION 3:** All Resolutions or parts of Resolutions in conflict herewith are hereby rescinded.
