**AN ORDINANCE AMENDING THE 2000 AIRPORT REVENUE BOND FUND BUDGET BY TRANSFERRING TO AND FROM APPROPRIATIONS IN THE AMOUNT OF \$5,827,040 TO PROVIDE ADEQUATE FUNDING FOR THE NORTH AIRFIELD LIGHTING VAULT RELOCATION - DEMOLITION FOR THE HARTSFIELD DEVELOPMENT PROGRAM AT HARTSFIELD ATLANTA INTERNATIONAL AIRPORT AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta ("City") advertised and solicited for FC-7547-02, North Airfield Lighting Vault Relocation - Demolition Project, for construction services to the Department of Aviation in connection with the East International Terminal Project; and

**WHEREAS**, the City of Atlanta has received bids from proponents and deemed one as the best, most responsive and responsible bid, as administered by the city's Chief Procurement Officer; and

**WHEREAS**, the City has negotiated an agreement with said proponent on the services to be provided to the City and the fee to be paid by the City under said Contract; and

**WHEREAS**, the Aviation General Manager, the Chief Procurement Officer, both recommend that the City of Atlanta enter into a contractual agreement with said proponent; and

**WHEREAS**, the source of project funding was originally set to utilize the Airport Renewal & Extension Fund; and

**WHEREAS**, the Department of Aviation has adjusted the original funding source so that the project may be funded using one of the Airport Revenue Bond Funds; and

**WHEREAS**, it is now necessary to amend the 2003 (2000 Airport Revenue Bond Fund) Budget to take advantage of funding the North Airfield Lighting Vault Relocation - Demolition Project with Bond Funds.

**NOW, THEREFORE, THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS** as follows:

**Section 1:** That the 2003 (2000 Airport Revenue Bond Fund) Budget be and hereby is amended as follows:
