**AMENDING SECTION 9 OF RESOLUTION 02-R-1671 ADOPTED BY CITY
COUNCIL ON NOVEMBER 4, 2002 AND APPROVED BY THE MAYOR ON
NOVEMBER 8, 2002, WHICH APPROVED PROJECTS UNDER THE 2003
ANNUAL ACTION PLAN OF THE 2000-2004 CONSOLIDATED PLAN; AND
FOR OTHER PURPOSES.**

WHEREAS, the City Council adopted and the Mayor on November 4, 2002 and November 8, 2002, respectively, Resolution 02-R-1671 which approved projects to be included in the 2002 Annual Action Plan of the 2000-2004 Consolidated Plan; and

WHEREAS, Section 9 of said resolution set forth conditions for the funding of the Sadie G. Mays Rehabilitation Center project that included *"the City documenting and evidencing funds raised (by the applicant) totaling the amount needed to satisfy other projects obligated for "Multi-Unit Housing" on the adoption of Resolution 02-R-1671"*; and

WHEREAS, it has been determined by the Department of Planning and Community Development that it is not necessary to make funding contingent upon the applicant raising funds in an amount needed to satisfy obligations in the Multi-Unit Housing project.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: That Resolution 02-R-1671 adopted by the City Council on November 4, 2002 and approved by the Mayor on November 8, 2002 be and is amended hereby by deleting Section 9 in its entirety and inserting in lieu thereof the following:

"That the Atlanta Association of Convalescent Aged Persons, Inc. provide a \$150,000.00 match to the City's funding for the design of the Sadie G. Mays rehabilitation Center prior to the City releasing its funding."

Section 2: That all resolutions and parts of resolutions in conflict with this resolution are hereby repealed.
