Dear Mrs. Johnson:

It gives me great pleasure to announce that the Ethics Board, on May 15, 2003, concluded its search for an ethics officer by unanimously selecting Virginia Looney to become the City's inaugural ethics officer.

The Ethics Board began its search to fill the position of ethics officer in December of last year. After receiving and reviewing applications from more than eighty (80) diverse and extremely well qualified applicants, the Ethics Board Hiring Committee reduced to eight (8) the number of candidates most worthy of an interview. Thereafter, the Ethics Board Hiring Committee, joined by Linda DiSantis, the City Attorney, personally interviewed the remaining eight (8) candidates on April 2, 2003. While all of the candidates exemplified many of the qualities the Hiring Committee deemed essential for the job of ethics officer, Virginia Looney was by far the preeminent candidate. Mrs. Looney has an excellent eighteen (18) year work history that includes both private and public sector experience and she made an excellent presentation before the Hiring Committee; she was the obvious choice for the Hiring Committee.

I have forwarded this notice to you so that you may, in keeping with the City's established policies and procedures, forward Mrs. Looney's candidacy to the City Council for their ratification and then to Mayor Franklin for her approval.
