A RESOLUTION TO AUTHORIZE THE COMMISSIONER OF THE DEPARTMENT OF PLANNING AND COMMUNITY DEVELOPMENT TO RE-EMPLOY AT HIS CURRENT SALARY LEVEL MR. JOHN A. BELL, A RETIRED EMPLOYEE OF THE CITY OF ATLANTA, BUREAU OF PLANNING UNDER PROVISIONS OF SECTION 3-505(c) OF THE CHARTER OF THE CITY OF ATLANTA FOR A PERIOD NOT TO EXCEED 520 BUSINESS DAYS SO AS TO PROVIDE CONTINUING SERVICES AS ASSISTANT DIRECTOR (ZONING ADMINISTRATOR) IN THE BUREAU OF PLANNING; AND FOR OTHER PURPOSES


WHEREAS, on September 3, 2002 the City Council of the City of Atlanta adopted and the Mayor subsequently approved Ordinance 02-0-1296 which provides, inter alia, that a retired City employee may be re-employed for a period not to exceed 520 business days if such employee is found to have particularized expertise which the City wishes to retain for a period of time subject to the approval of the City Council; and

WHEREAS, Mr. John A. Bell has been employed as an Assistant Director of the Bureau of Planning and serves as the City's Zoning Administrator; and

WHEREAS, Mr. Bell has over twenty (20) years experience in administering the City of Atlanta Zoning Ordinance and the sudden loss of this expertise will seriously hamper the effective implementation of this important regulatory function of the city; and

WHEREAS, the Department of Planning and Community Development wishes to retain Mr. Bell's services upon his retirement as provided for by Ordinance 02-0-1296 for the purpose of ensuring a smooth continuation of the City's Zoning process.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, that the Commissioner of the Department of Planning and Community



Development be and is hereby authorized to employ Mr. John A. Bell, upon his retirement, in accordance with the provisions of Section 3-505(c) of the Charter of the City of Atlanta, to provide services to the Department of Planning and Community Development as Assistant Director, (Zoning Administrator), Bureau of Planning. Said reemployment to be at Mr. Bell's current salary level (Range 27, Step 10, \$67,751)
