



SUBSTITUTE RESOLUTION BY

FINANCE/EXECUTIVE COMMITTEE

AUTHORIZING AN EXTENSION OF THE TERM OF FC-5780-94, LEASE AGREEMENT FOR DUTY FREE, JV RETAIL CONCESSION CONCOURSE "E" WITH HOST ATLANTA DUTY FREE, JV ON A MONTH-TO-MONTH BASIS NOT TO EXCEED THREE (3) MONTHS UNTIL A NEW CONTRACT BECOMES EFFECTIVE; ALL TERMS AND CONDITIONS SHALL REMAIN THE SAME.

WHEREAS, Host Atlanta Duty Free, JV is currently the contractor for FC-5780-94, Lease Agreement for Duty Free Retail Concession Concourse "E", which has expired; and

WHEREAS, the City of Atlanta (the "City") did advertise for new proposals under FC-7313-01, Concourse "E" – Duty Free; and


WHEREAS, proposals were received and are pending the recommendation of the Department of Aviation; and

WHEREAS, it is necessary to provide for the continuation of the services under the same terms and conditions as the existing contract on a month-to-month basis until a new contract becomes effective or until the services are cancelled by the City upon thirty (30) days prior written notice to Host Atlanta Duty Free, JV.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that FC-5780-94, Lease Agreement for Duty Free Retail Concession Concourse "E" with Host Atlanta Duty Free, JV be extended on a month-to-month basis not to exceed three (3) months until a new contract becomes effective or until it is cancelled by the City upon thirty (30) days prior written notice to Host Atlanta Duty Free, JV, with all other terms and conditions thereof to continue in full force and effect.

BE IT FURTHER RESOLVED, that all revenues generated under this contract shall be deposited into the appropriate Fund, Account and Center numbers.
