**SUBSTITUTE RESOLUTION BY
FINANCE/EXECUTIVE COMMITTEE**

AUTHORIZING AN EXTENSION OF THE TERM OF FC-6659-96, CITYWIDE SECURITY GUARD SERVICES WITH BARTON PROTECTIVE SERVICES, INC. D/B/A CONTINENTAL SECURITY SERVICES ON A MONTH-TO-MONTH BASIS NOT TO EXCEED SIX (6) MONTHS UNTIL A NEW CONTRACT BECOMES EFFECTIVE; ALL TERMS AND CONDITIONS SHALL REMAIN THE SAME.

WHEREAS, Barton Protective Services, Inc. d/b/a Continental Security Services is currently the contractor for FC-6659-96, Citywide Security Guard Services, which has expired; and


WHEREAS, the City of Atlanta (the "City"), Department of Procurement is in the process of preparing the solicitation documents for advertisement; and

WHEREAS, it is necessary to provide for the continuation of the services under the same terms and conditions as the existing contract on a month-to-month basis until a new contract becomes effective or until the services are cancelled by the City upon thirty (30) days prior written notice to Barton Protective Services, Inc. d/b/a Continental Security Services.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that FC-6659-96, Citywide Security Guard Services with Barton Protective Services, Inc. d/b/a Continental Security Services be extended on a month-to-month basis not to exceed six (6) months until a new contract becomes effective or until it is cancelled by the City upon thirty (30) days prior written notice to Continental Security, with all other terms and conditions thereof to continue in full force and effect.

BE IT FURTHER RESOLVED, that all contracted work shall be charged to and paid from various Fund Account and Center numbers.
