



FINANCE/EXECUTIVE COMMITTEE

AUTHORIZING AN EXTENSION OF THE TERM OF FC-5914-94, PUBLIC PAY TELEPHONE CONCESSIONS WITH AT&T CORP, KELLEE COMMUNICATIONS GROUP, INC., AND PEOPLES TELEPHONE COMPANY, INC. D/B/A AT&T/KELLEE & PEOPLES, JV ON A MONTH-TO-MONTH BASIS NOT TO EXCEED THREE (3) MONTHS UNTIL A NEW CONTRACT BECOMES EFFECTIVE; ALL TERMS AND CONDITIONS SHALL REMAIN THE SAME.

WHEREAS, AT&T Corp., Kellee Communications Group, Inc., and Peoples Telephone Company, Inc. d/b/a AT&T/Kellee & Peoples, JV is currently the contractor for FC-5917-94, Public Pay Telephone Concessions, which has expired; and

WHEREAS, the City of Atlanta (the "City") did advertise for new proposals under FC-7427-02, Public Pay Phone Concession; and

WHEREAS, proposals were received and the Department of Aviation recommended that AT&T Corporation be awarded the contract for FC-7427-02, Public Pay Phone Concession; and


WHEREAS, the contract for FC-7427-02, Public Pay Phone Concession is currently in the signature routing process; and

WHEREAS, it is necessary to provide for the continuation of the services under the same terms and conditions as the existing contract on a month-to-month basis until a new contract becomes effective or until the services are cancelled by the City upon thirty (30) days prior written notice to AT&T Corp., Kellee Communications Group, Inc., and Peoples Telephone Company, Inc. d/b/a AT&T/Kellee & Peoples, JV.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that FC-5914-94, Public Pay Telephone Concessions with AT&T Corp, Kellee Communications Group, Inc. and Peoples Telephone Company, Inc. d/b/a AT&T/Kellee Communications & Peoples, JV be extended on a month-to-month basis not to exceed three (3) months until a new contract becomes effective or until it is cancelled by the City upon thirty (30) days prior written notice to AT&T/Kellee Communications & Peoples JV, with all other terms and conditions thereof to continue in full force and effect.

BE IT FURTHER RESOLVED, that all revenues generated under this contract shall be deposited into the appropriate Fund Account and Center numbers.
