WHEREAS, the City did advertise for new proposals under FC-7552-03, Citywide Vending Concession Services; and


WHEREAS, proposals were received and the proposals are currently being evaluated by the Office of General Services; and

WHEREAS, it is necessary to provide for the continuation of the services under the same terms and conditions as the existing contract on a month-to-month basis until a new contract becomes effective or until the services are cancelled by the City upon thirty (30) days prior written notice to Rowe Concessions, Inc.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that FC-6532-96, Vending Machine Services with Rowe Concessions, Inc. be extended on a month-to-month basis not to exceed two (2) months until a new contract becomes effective or until it is cancelled by the City upon thirty (30) days prior written notice to Rowe Concessions, Inc., with all other terms and conditions thereof to continue in full force and effect.

BE IT FURTHER RESOLVED, that all revenues generated under this contract shall be deposited into the appropriate Fund, Account and Center numbers.
