A RESOLUTION

A RESOLUTION AUTHORIZING THE MAYOR TO SIGN TWO GRANT AGREEMENTS WITH THE GEORGIA DEPARTMENT OF TRANSPORTATION FOR THE GREENBRIAR AND THE WEST END LIVABLE COMMUNITIES INITIATIVE (LCI) DESIGN PROJECTS; AND FOR OTHER PURPOSES.

WHEREAS, Ordinance 03-0-0547 was adopted by the City Council on May 05, 2003 and signed by the Mayor on May 13, 2003; and

WHEREAS, Ordinance 03-0-0547 appropriated federal transportation funds for project design work for the Greenbriar and the West End LCI projects in the amount of \$122,625.00 and authorized the Mayor to sign grant agreements with the Atlanta Regional Commission for these projects; and

WHEREAS, the Georgia Department of Transportation has since decided not to administer these contracts utilizing the staff resources of the Atlanta Regional Commission; and


WHEREAS, these contracts have been received by the City for signature authorizing the contracts with the Georgia Department of Transportation.

NOW, THEREFORE THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY RESOLVES as follows:

Section 1. That the Mayor is hereby authorized to sign a grant agreement with the Georgia Department of Transportation for the (1) Greenbriar LCI project for an amount not to exceed \$80,000. and for the (2) West End LCI project for an amount not to exceed \$42,625. That said projects will be charged to and paid from those accounts as established in Ordinance 03-0-0547.

Section 2. All resolutions and parts of resolutions in conflict with this resolution are hereby rescinded to the extent of any such conflict.

AN ORDINANCE AUTHORIZING THE MAYOR TO ACCEPT TWO GRANTS FROM THE ATLANTA REGIONAL COMMISSION TO CONDUCT PROJECT DESIGN WORK FOR THE GREENBRIAR AND THE WEST END LIVABLE CENTERS INITIATIVE (LCI) PROJECTS; AND AUTHORIZING THE MAYOR TO SIGN A GRANT AGREEMENT FOR EACH DESIGN STUDY; AND AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH CENTRAL ATLANTA PROGRESS FOR AN AMOUNT NOT TO EXCEED \$20,000. FOR THE CENTER CITY LCI PROJECT: AND INCREASING THE ESTIMATED RECEIPTS IN THE 2003 INTERGOVERNMENTAL GRANT FUND BY \$142, 625; AND FOR OTHER PURPOSES.

WHEREAS, Resolution 01-R-0967 was approved by the City Council on October 1, 2001 and signed by the Mayor on October 9, 2001 adopting the the West End LCI project and Resolution 01-R-0971 was approved by the City Council on August 6, 2001 and signed by the Mayor on August 13, 2001 adopting the Greenbriar LCI project; and

WHEREAS, the West End project was approved by ARC for funding in the amount of \$1.6 million and the Greenbriar project was approved for funding in the amount of \$2.5 million for certain infrastructure/transportation projects that were summarized in the implementation section of each project; and

WHEREAS, Resolution 01-R-1975 was approved by the City Council on December 03, 2001 and signed by the Mayor on December 11, 2001 adopting Central Atlanta Progress Center City LCI project; and

WHEREAS, in the 2003-2005 Transportation Improvement Plan (TIP) the Atlanta Regional Commission has awarded the City of Atlanta \$142,625.00 to conduct the project design work for each project; and

WHEREAS, match funds for the Greenbriar and West End projects were allocated in the Quality of Life Bond funds allocations; and

WHEREAS, each project requires a 20% match and match funds for the Greenbriar and the West End Project have been identified in accounts 1C45 1CY63061592BG and 1C45 Y63F062292BG respectively; and



WHEREAS, the Budget Commission of the City of Atlanta has recommended increasing estimated receipts in the Intergovernmental Fund by \$142, 625.00

NOW, THEREFORE IT IS ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA AS FOLLOWS:

Section 1: Matching funds for these two projects of \$16,000.00 for the Greenbriar LCI project and \$8,525.00 for the West End LCI project have been identified in the following accounts.




