

AN ORDINANCE

An Ordinance to name the new International Terminal at Hartsfield International Airport, **the Maynard Holbrook Jackson, Jr. International Terminal** in honor of Atlanta's former Mayor

WHEREAS, Maynard Holbrook Jackson was elected the first black Mayor of a major southern City in 1973; and

WHEREAS, Mayor Jackson served two terms as Atlanta's Mayor from 1974 through 1981, and a third term, from 1989-1993; and

WHEREAS, Mayor Jackson was instrumental in the expansion of the city's airport into a world class facility, that was built on time and under budget; and

WHEREAS, Hartsfield Atlanta International Airport is now the busiest airport in the world; and

WHEREAS, Mayor Maynard Holbrook Jackson, Jr. died June 23, 2003; and

WHEREAS, it is fitting that the City and its citizens honor his great legacy in some way; and

WHEREAS, the City has begun site preparation for a new international terminal; and

WHEREAS, this will be a state of the art facility that will be a ten-gate extension of the present international terminal building that will handle both domestic and international flights; and

WHEREAS, this facility is slated to be completed in late 2006 or early 2007; and

WHEREAS, the naming of the new International Terminal would honor his memory in an appropriate manner.

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF
ATLANTA, GEORGIA** as follows:

Section 1: That the new International Terminal at Hartsfield Atlanta International be named the Maynard Holbrook Jackson, Jr. International Terminal.

Section 2: That all ordinances and parts of ordinances in conflict herewith are hereby repealed
