A RESOLUTION AUTHORIZING THE AVIATION GENERAL MANAGER TO ISSUE WORK AUTHORIZATION NO. 2 TO AVIATION CONSULTING TEAM FOR FC-7370-01, ARCHITECTURAL AND ENGINEERING DESIGN SUPPORT SERVICES, IN AN AMOUNT NOT TO EXCEED ONE MILLION THREE HUNDRED FIFTY THOUSAND DOLLARS (\$1,350,000.00) FOR ARCHITECTURAL AND ENGINEERING DESIGN OF THE AVIATION BOULEVARD RECONFIRGURATION IN SUPPORT OF THE EAST INTERNATIONAL TERMINAL PROJECT AT HARTSFIELD ATLANTA INTERNATIONAL AIRPORT. ALL CONTRACTED WORK SHALL BE CHARGED TO AND PAID FROM FUND, ACCOUNT AND CENTER NUMBER 2H21 524001 R21E10209999.

WHEREAS, the City of Atlanta (the "City"), as owner and operator of the Hartsfield Atlanta International Airport, has undertaken a major expansion of the Airport to accommodate the increasing air traffic, including the construction of a new East International Terminal; and

WHEREAS, the City has engaged the services of Architectural and Engineering ("A&E") Firms to perform on-call services in connection with the expansion project; and

WHEREAS, the A&E contracts require issuance of a Work Authorization for each project assigned by the Department of Aviation; and

WHEREAS, the preferred concept for the East International Terminal will require a major reconfiguration of Aviation Boulevard and is now ready to be assigned to an Engineering Design Firm; and

WHEREAS, in connection therewith, the City finds it in its best interest to award this project to Aviation Consulting Team, through its Architectural and Engineering Design Support Services Contract.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Aviation General Manager be and is hereby authorized to issue Work Authorization No. 2 to Aviation Consulting Team, for FC-7370-01, Architectural and Engineering Design Support for the design of the Aviation Boulevard reconfiguration in an amount not to exceed One Million Three Hundred Fifty Dollars (\$1,350,000.00).

BE IT FURTHER RESOLVED, that all work contracted shall be charged to and paid from Fund, Account, and Center Number: 2H21-524001-R21E10209999.

BE IT FURTHER RESOLVED, that the Aviation General Manager be and is hereby directed to prepare and execute an appropriate Work Authorization.

BE IT FINALLY RESOLVED, that this Work Authorization shall not become binding on the City and the City shall incur no liability upon same until such Work Authorization has been issued and delivered to the contracting parties.
