AN ORDINANCE BY

AN ORDINANCE TO AMEND SECTION 138-60 OF THE CODE OF ORDINANCES OF THE CITY OF ATLANTA FOR THE PURPOSE OF SETTING UNIFORM FEES FOR ORGANIZATIONS, INCLUDING FOR-PROFIT CORPORATIONS, NON-PROFIT CORPORATIONS AND CHARITABLE ORGANIZATIONS THAT USE THE CITY'S RIGHTS OF WAY (R-O-W) TO DISPLAY BANNERS; AND FOR OTHER PURPOSES.

WHEREAS, Ordinance 00-O-1289 was adopted by the Atlanta City Council on December 4, 2000 and was approved by the Mayor on December 12, 2000 to amend the Code of Ordinances by effectively setting an additional fee to be imposed when permits are granted to businesses and organizations to use the City's right of way for longer than 30 days and/or to hang more than 100 banners,

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That the Atlanta Code of Ordinances Section 138-60, subsection (a)(8) be amended in its entirety to read as follows:

(8) The base fee for a permit shall be \$100.00 (plus a \$1,000.00 refundable deposit per subsection (a)(7) of this Code Section). Additional fees shall be assessed for all corporations and organizations, including but not limited to for-profit corporations, non-profit corporations and charitable organizations, in the amount of \$1.80 per banner for each permitted day.

SECTION 2: That all ordinances and parts of ordinances in conflict herewith be and are hereby repealed.




