AN ORDINANCE

AN ORDINANCE AUTHORIZING THE MAYOR OR HER DESIGNEE TO INSTALL A THREE-WAY STOP SIGN AT THE INTERSECTION OF POWERS FERRY ROAD, NW AND TUXEDO TERRACE, NW; AND FOR OTHER PURPOSES.

WHEREAS, there is significant vehicular traffic traveling on Powers Ferry Road, NW at the intersection of Tuxedo Terrace, NW; and

WHEREAS, the amount and speed of this traffic make it difficult for vehicular and pedestrian traffic to enter and/or cross Powers Ferry Road, NW at Tuxedo Terrace, NW; and

WHEREAS, residents of the neighborhood surrounding the intersection of Powers Ferry Road, NW at Tuxedo Terrace, NW have expressed their concern for this situation and the need for a Three-Way Stop Sign at this intersection; and

WHEREAS, the lack of a Three-Way Stop Sign at this intersection creates a significant hazard and public safety risk to all of the residents of the area; and

WHEREAS, the installation of a Three-Way Stop Sign would enhance the safety and reduce the potential of a public safety risk to all of the residents of the neighborhood.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA:

SECTION ONE: That the Department of Public Works, Traffic and Transportation Division conduct a traffic study; with the intent to install a Three-Way Stop Sign at the intersection of Powers Ferry Road, NW at Tuxedo Terrace, NW.

SECTION TWO: All ordinances or parts of ordinances in conflict herewith be and the same are hereby repealed.
