**AN ORDINANCE**

**AN ORDINANCE AUTHORIZING THE MAYOR OR HER DESIGNEE TO INSTALL A FOUR-WAY STOP SIGN AT THE INTERSECTION OF HABERSHAM ROAD, NW AND VALLEY ROAD; AND FOR OTHER PURPOSES.**

**WHEREAS**, there is significant vehicular traffic traveling on Habersham Road, NW at the intersection of Valley Road, NW; and

**WHEREAS**, the amount and speed of this traffic make it difficult for vehicular and pedestrian traffic to enter and/or cross Habersham Road, NW at Valley Road, NW; and

**WHEREAS**, residents of the neighborhood surrounding the intersection of Habersham Road, NW at Valley Road, NW have expressed their concern for this situation and the need for a Three-Way Stop Sign at this intersection; and

**WHEREAS**, the lack of a Four-Way Stop Sign at this intersection creates a significant hazard and public safety risk to all of the residents of the area; and

**WHEREAS**, the installation of a Four-Way Stop Sign would enhance the safety and reduce the potential of a public safety risk to all of the residents of the neighborhood.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA:**

**SECTION ONE:** That the Department of Public Works, Traffic and Transportation Division conduct a traffic study; with the intent to install a Four-Way Stop Sign at the intersection of Habersham Road, NW and Valley Road.

**SECTION TWO:** All ordinances or parts of ordinances in conflict herewith be and the same are hereby repealed.
