AS SUBSTITUTED BY FINANCE/EXECUTIVE COMMITTEE**

**AN ORDINANCE TO AMEND ARTICLE "V" CLASSIFICATION PLAN, SECTION 114-477, OF THE CODE OF ORDINANCES, CITY OF ATLANTA, GEORGIA, SO AS TO ADJUST THE SALARY OF THE FIRE CHIEF, THE "SWORN FIRE AND CORRECTIONS PUBLIC SAFETY EMPLOYEES SALARY SCHEDULE, AND THE COMMISSIONER OF PARKS, RECREATION AND CULTURAL AFFAIRS", AUTHORIZE ABOVE ENTRY HIRING; AND FOR OTHER PURPOSES.**

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS:** That Section 114-477, of the Code of Ordinances, City of Atlanta, Georgia, be and the same is hereby amended as follows:

**SECTION 1 - EFFECTIVE DATE OF ACTIONS:** That the effective date for actions contained within this ordinance shall be the beginning date of the pay period following adoption by Council and approval by the Mayor, or the date this ordinance becomes effective without such approvals per City Charter Section 2-403.

**SECTION 2 – SALARY SCHEDULE ADJUSTMENT:** That section 114-477, Adopted by Reference, is hereby amended to include the following:

Salary Schedule “Sworn Fire and Corrections Public Safety Employees” is hereby amended to increase salaries in Salary Grade 50-PS by \$20,000.00.”

**SECTION 3 – CLASS SALARY GRADE AMENDMENTS WITHOUT INCUMBENT:** That the salary grade of the following classification be and the same is hereby amended as indicated:
