AN AMENDED RESOLUTION

A RESOLUTION AUTHORIZING THE MAYOR OR DESIGNEE TO ENTER INTO AN APPROPRIATE RENEWAL AGREEMENT NUMBER ONE WITH COMPLIANCE ENVIROSYSTEMS, L.L.C., FOR FC-7345-01, SANITARY SEWER EVALUATION SURVEY CONTRACT "B" ON BEHALF OF THE DEPARTMENT OF WATERSHED MANAGEMENT IN AN AMOUNT NOT TO EXCEED THREE MILLION FOUR HUNDRED EIGHTY-SIX THOUSAND EIGHT HUNDRED TWENTY DOLLARS (\$3,486,820.00). ALL CONTRACTED WORK SHALL BE CHARGED TO AND PAID FROM FUND ACCOUNT AND CENTER NUMBER: 2J27 524001 Q38I22029999.

WHEREAS, the City of Atlanta (the "City") did enter into an agreement with Compliance EnviroSystems, L.L.C., for FC-7345-01, Sanitary Sewer Evaluation Survey Contract "B" on behalf of the Department of Watershed Management; and

WHEREAS, said agreement contained two (2) one (1) year renewal options; and

WHEREAS, the Contractor has performed the contracted services satisfactorily; and

WHEREAS, the Commissioner of Department of Watershed Management and the Chief Procurement Officer of the Department of Procurement have recommended Renewal Agreement Number One for FC-7345-01, Sanitary Sewer Evaluation Survey Contract "B" with Compliance EnviroSystems, L.L.C.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor be and is hereby authorized to enter into Renewal Agreement Number One with Compliance EnviroSystems, L.L.C., for FC-7345-01, Sanitary Sewer Evaluation Survey Contract "B" for a period of one year in an amount not to exceed three million four hundred eighty-six thousand eight hundred twenty dollars (\$3,486,820.00).

BE IT FURTHER RESOLVED, that the Chief Procurement Officer is hereby directed to prepare an appropriate renewal agreement for execution by the Mayor to be approved by the City Attorney as to form.

BE IT FURTHER RESOLVED, that this agreement shall not become binding on the City, and the City shall incur no liability upon same until such agreement has been executed by the Mayor and delivered to the contracting party.

BE IT FINALLY RESOLVED, that all services for said renewal shall be charged to and paid from fund account and center number: 2J27 524001 Q38I22029999.
