



**A RESOLUTION TO RESCHEDULE THE REGULAR MEETING OF THE ATLANTA CITY COUNCIL TO 9:00 A.M., THURSDAY NOVEMBER 20, 2003 PURSUANT TO THE AUTHORITY OF SECTION 2-303 MEETINGS, OF THE ATLANTA CITY CODE OF ORDINANCES.**

**WHEREAS**, to meet the needs of the City, it is necessary to reschedule the November 17, 2003 meeting of the City Council to 9:00 a.m., Thursday November 20, 2003.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA**, that

**SECTION 1:** Section 2-303 "Meetings" Subsection (a) of the Atlanta City Code of Ordinances reads in part "For good cause shown, the Council may reschedule a regular Monday council meeting to another day, provided that notice pursuant to O.C.G.A. § 50-14-1 is given."

**SECTION 2:** The Council in its desire to adopt the Mayor's proposed 2004 Budget in a timely manner and because of legal requirements involving notice to the public for the establishment or change in fees for service has determined that the November 17, 2003 regular meeting of Council shall be rescheduled to 9:00 a.m. November 20, 2003.

**SECTION 3:** That all resolutions or parts thereof in conflict herewith are hereby repealed.
