



**AN ORDINANCE BY
COUNCILMEMBER DERRICK BOAZMAN
AS SUBSTITUTED BY ATLANTA CITY COUNCIL**

**AMENDING THE CITY OF ATLANTA CODE
OF ORDINANCES SECTION 2-407 OUTSIDE
COUNSEL; AND FOR OTHER PURPOSES**

WHEREAS, it is the duty and responsibility of the City Council to adopt contracts that are entered into by the City of Atlanta; and

WHEREAS, the City of Atlanta Code of Ordinances requires that any outside counsel contract entered into by the City Attorney which anticipates spending more than \$50,000.00 seek the approval of the Atlanta City Council; and

WHEREAS, a defined scope of work of the intended service contract would provide the necessary information that could identify the approximate amount of the proposed contract; and

WHEREAS, this information should be readily available from the Department of Law and the Office of Procurement Services; and

WHEREAS, the Atlanta City Council as the policy maker of the City is properly included in this type of decision as provided by the City of Atlanta Code of Ordinances.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA; as follows:

Section 1: That Section 2-407 entitled "Outside Counsel" is hereby amended to add the following paragraph.

The City Attorney shall provide on a monthly basis in writing to all City Councilmembers a list of all outside counsel currently retained or engaged by the Law Department including whether the general type of work being performed or to be performed by such counsel is "civil" "criminal" or "transactional" in nature

Section 2: That all ordinances or parts of ordinances in conflict herewith be and the same are hereby repealed.
