A RESOLUTION ESTABLISHING THE COMPENSATION LIMITS FOR US INFRASTRUCTURE, INC. FOR FC-7259-00, PROFESSIONAL SERVICES FOR GREENWAY ACQUISITION, DURING THE SECOND YEAR OF PHASE I FROM JANUARY 1, 2004 THROUGH DECEMBER 31, 2004, PURSUANT TO THE TERMS AND CONDITIONS OF THE CONTRACT, IN AN AMOUNT NOT TO EXCEED \$1,986,915.00 TO BE CHARGED AND PAID FROM FUND, ACCOUNT AND CENTER NUMBER: 2J26 524001 Q31I04019999; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (the "City") did enter into contract FC-7259-00, Professional Services for Greenway Acquisition for property acquisition services for Greenway Properties along "Designated Streams" as defined by the CSO Consent Decree for seven (7) years on behalf of the Department of Watershed Management pursuant to Resolution (00-R-2091), adopted on January 2, 2001; and approved by the Mayor on January 8, 2001; and

WHEREAS, the Contract provides that compensation limits for Phase I and subsequent years shall be established annually by the Department of Watershed Management, subject to approval of the City Council of the total not to exceed cost to the City during each year; and

WHEREAS, the Commissioner of the Department of Watershed Management desires to establish compensation limits for the second year of Phase I in an amount not to exceed \$1,986,915.00; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the compensation limits for Phase I of the terms of said Contract, FC-7259-00, Professional Service for Greenway Acquisition, with US Infrastructure, Inc. be and hereby are established in accordance with the applicable provisions thereof up to a total amount not to exceed \$1,986,915.00.

BE IT FINALLY RESOLVED, that all services for said agreement shall be charged to and paid from Fund, Account and Center Number: 2J26 524001 Q31I04019999.


