AS AMENDED BY FINANCE/EXECUTIVE COMMITTEE

A RESOLUTION REQUESTING THAT THE GEORGIA STATE LEGISLATURE NOT CONSIDER THE INCORPORATION OF SANDY SPRINGS UNTIL IT HAS BEEN DETERMINED THAT SUCH A MOVE WOULD BE REVENUE NEUTRAL TO THE TAXPAYERS OF THE CITY OF ATLANTA AND FULTON COUNTY

WHEREAS, Sandy Springs is an unincorporated area in Fulton County, Georgia; and for many years, has desired to become an incorporated municipality; and

WHEREAS, the City of Atlanta has consistently opposed the incorporation of a City of Sandy Springs; and

WHEREAS, the incorporation of Sandy Springs would decrease revenues to Fulton County, thereby increasing the tax burden of other Fulton Counties; and

WHEREAS, such incorporation would decrease the portion of the LOST (local option sales tax) revenue to already-incorporated municipalities in the county; and

WHEREAS, in 1998, as a part of its Legislative package, the City of Atlanta requested that further studies of the areas in unincorporated Fulton County.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

Section 1: That the City of Atlanta hereby opposes the incorporation of the City of Sandy Springs, and requests that the Georgia State Legislature not approve such incorporation unless and until it is determined that such incorporation will not adversely affect neither the taxpayers of the City of Atlanta, or the taxpayers of Fulton County.

Section 2: That the Chief Financial Officer of the City of Atlanta is hereby directed to analyze all previous data and generate the necessary new data to determine the effects of the incorporation of Sandy Springs.
