AN ORDINANCE TO AMEND THE 2004 GENERAL FUND BUDGET AND THE TRUST FUND BUDGET BY TRANSFERRING APPROPRIATIONS OF \$101,000 FROM THE GENERAL FUND 1A01 724001 S11001 (Consultant and Professional Services) TO 1A01 762001 S11001 (Interfund Operating Transfer) AND BY ANTICIPATING AND APPROPRIATING \$101,000.00 IN THE TRUST FUND 3P02 S11T2101QNAO FOR THE COMMUNITY COURT FOUNDATION.

WHEREAS, The Atlanta City Council by Resolution did establish the Community Court Foundation (O3-R-2246) and is desirous of funding a position within the Community Court to work toward the establishment of the Foundation for a period of one year, as a demonstration project, said person to be a Community Court Coordinator (position # 53514 Grade 22/ Step 5).
