**A RESOLUTION AUTHORIZING THE MAYOR OR DESIGNEE TO ENTER INTO RENEWAL AGREEMENT NO. 3 WITH PROFESSIONAL PROBATION SERVICES, INC., FOR FC-7087-99, PRIVATIZATION OF PROBATION SERVICES, ON BEHALF OF CITY COURT OF ATLANTA THE CONTRACT SHALL BE REVENUE GENERATING AND FUNDS SHALL BE DEPOSITED IN FUND ACCOUNT AND CENTER NUMBER: 1B05 451101 B00001 (TRAFFIC COURT OPERATIONS FUND).**

**WHEREAS**, the City of Atlanta (the "City") did enter into an agreement with Professional Probation Services, Inc., for FC-7087-99, Privatization of Probation Services, on behalf of the City Court of Atlanta; and

**WHEREAS**, said contract provided for three (3), one (1) year renewal options; and

**WHEREAS**, the contractor has performed contracted services satisfactorily; and

**WHEREAS**, the Chief Judge of the City Court of Atlanta and the Chief Procurement Officer have recommended Renewal No. 3 for FC-7087-99, Privatization of Probation Services be renewed for additional one year period.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA**, that the Mayor be and is hereby authorized to enter into an Renewal Agreement No. 3 with Professional Probation Services, Inc., for FC-7087-99, Privatization of Probation Services, on behalf of the City Court of Atlanta.

**BE IT FURTHER RESOLVED**, that the Chief Procurement Officer be and is hereby directed to prepare an appropriate renewal agreement for execution by the Mayor and to approved by the City Attorney as to form.

**BE IT FURTHER RESOLVED**, that this renewal agreement shall not become binding on the City, and the City shall incur no liability upon same until such agreement has been executed by the Mayor and delivered to the contracting party.

**BE IT FURTHER RESOLVED**, that all revenue generated from said contracted work shall be Deposited into Fund, Account and Center Number: 1B05 451101 B00001 (Traffic Court Operations).


