**AN ORDINANCE AUTHORIZING THE MAYOR OR HER DESIGNEE TO MAKE CHAUCER DRIVE, SW A THREE WAY STOP WHERE IT INTERSECTS WITH HARLAN ROAD, SW; AND FOR OTHER PURPOSES.**

**WHEREAS**, there is an increasingly number of vehicles that are traveling along Peyton Road, SW to get to I-285 and Cascade Road; and

**WHEREAS**, there are many families in the area which households run the gambit of senior citizens to elementary age children; and

**WHEREAS**, residents in the Peyton Forest Community have expressed their concerns regarding the high volume of traffic that passes through this corridor which creates problems for residents trying to leave their subdivision especially during the morning and evening rush hour; and

**WHEREAS**, the lack of a three way stop signs poses a significant hazard and public safety risk to all the residents living in Mays Manor.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA** as follows:

**SECTION 1:** That Stop Signs be placed at Chaucer Drive, SW where it intersects with Harlan Road, SW making the intersection a Three Way Stop.

**SECTION 2:** That all ordinances and parts of ordinances in conflict herewith be and the same are hereby waived.
