**An Ordinance  
By Councilmember Natalyn Archibong**

An Ordinance to amend Section 106-403(a) of the Code of Ordinances of the City of Atlanta, Georgia so as to correct the descriptions of the Drug-Free Commercial Zones designated as "Zone VI, Memorial Drive" and "Zone VI, Whiteford"; to delete the Zone presently designated as "Zone VI, Dekalb Avenue" which is rendered unnecessary by this amendment; to repeal conflicting Ordinances; and for other purposes.

**Whereas**, Section 106-403(a) of the Code of Ordinances of the City of Atlanta, Georgia contains certain errors in the descriptions of the Drug-Free Commercial Zones designated as "Zone VI, Memorial Drive" and "Zone VI, Whiteford"; and

**Whereas**, said descriptions must be corrected so that they may be advertised as required by O.C.G.A 16-13-32.6(d);

**NOW, THEREFORE, THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS AS FOLLOWS:**


**Section 1:** Section 106-403(a) of the Code of Ordinances of the City of Atlanta, Georgia which presently contains the following description of "Zone VI, Memorial Drive":

An area contained within a northern boundary of Memorial Drive; a southern boundary of Portland Avenue; a western boundary of Glenwood Memorial; an eastern boundary of Flat Shoals Avenue",

Is hereby amended to provide as follows:

"Zone VI, Memorial Drive: An area contained within a northern boundary of Memorial Drive; a southern boundary of Portland Avenue and proceeding westerly along Portland Avenue to Glenwood Place, thence northerly along Glenwood Place to Glenwood Avenue, thence westerly on Glenwood Avenue; a western boundary of the Glenwood Memorial Connector ; an eastern boundary of Flat Shoals Avenue."

**Section 2:** Section 106-403(a) of the Code of Ordinances of the City of Atlanta, Georgia which presently contains the following description of "Zone VI, Whiteford":




“An area contained within a northern boundary of Dekalb Avenue; a southern boundary of Memorial Drive; a western boundary of Moreland Avenue; an eastern boundary of Rogers Avenue.;

Is hereby amended by changing “Whiteford” to “Dekalb Avenue” and by changing “Rogers Avenue” to “Rogers Street” so that when amended, said zone shall be described as follows:

“Zone VI, Dekalb Avenue; An area contained within a northern boundary of Dekalb Avenue; a southern boundary of Memorial Drive; a western Boundary of Moreland Avenue; an eastern boundary of Rogers Street”.

**Section 3:** By amending the Drug-Free Commercial Zone entitled “Zone VI, Whiteford” in the manner described in Section 2 above, the Drug-Free Commercial Zone presently designated in Section 106-403(a) as “Dekalb Avenue” is rendered unnecessary and is therefore deleted from said Code Section.”

**Section 4:** All Ordinances and parts of Ordinances in conflict herewith are hereby repealed.
