AN ORDINANCE AMENDING THE 2004 (1994 REFERENDUM GENERAL OBLIGATION BOND FUND) BUDGET IN THE AMOUNT OF \$2,665,174.36 FOR COMPLETION OF THE HOWELL MILL CHATAHOCHEE INTERSECTION IMPROVEMENTS; AND FOR OTHER PURPOSES.

WHEREAS, a bond referendum was approved by voters July 19, 1994 for public improvement projects; and

WHEREAS, Planned Northside Drive Intersection Improvements and Howell Mill Road Widening projects were included as part of the public improvements approved by the referendum; and

WHEREAS, Funds in the amount of \$1,383,289.00, which were earmarked for the Northside Drive Intersection Improvements and Howell Mill Road Widening projects, were used to complete the Roxboro Road Widening Project; and

WHEREAS, all other projects funded by this bond referendum have been completed; and

WHEREAS, currently there are not enough funds to cover the cost of completion of both the Northside Drive Intersection Improvements and Howell Mill Road Widening projects; and

WHEREAS, the community has set a priority on the completion of the Howell Mill Road Widening project;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA:
