WHEREAS, the Georgia Legislature, upon amending the composition of the Atlanta/Fulton County Library Board of Trustees, granted to the City of Atlanta two seats on the Board, and required that one of the two seats be held by a resident of that portion of the City of Atlanta which is located within Dekalb County; and

WHEREAS, Councilmember Natalyn Mosby Archibong has expressed interest in serving on this board, and has agreed to serve; and

WHEREAS, the Atlanta City Council is desirous of having Councilmember Archibong serve in this position.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

Section 1: That Councilmember Natalyn Mosby Archibong, Council District 5, is hereby elected to serve a two year term as the Atlanta-in-Dekalb representative on the Atlanta/Fulton County Library Board of Trustees beginning on the date of this adopted resolution.

Section 2: That the Municipal Clerk is hereby instructed to forward a copy of this resolution to the Atlanta/Fulton County Library Board of Trustees notifying the Board of said election of Councilmember Archibong to serve as the City/County appointee to said Board.

Section 3: That all resolutions and parts of resolutions in conflict herewith are hereby waived.
