\$1,784,634.00 FOR THE SUMMER FOOD SERVICE
PROGRAM FOR THE PERIOD DECEMBER 1, 2003
THROUGH NOVEMBER 30, 2004; AND FOR OTHER
PURPOSES.**

WHEREAS, the State of Georgia's Office of School Readiness has notified the City of Atlanta of the availability of funding for the Summer Food Service Program for Children in an amount not to exceed \$1,784,634.00 for the period December 1, 2003 through November 30, 2004; and

WHEREAS, the Budget Commission of the City of Atlanta, Georgia has recommended increasing estimated receipts in the Intergovernmental Grant Fund by \$1,784,634.00.


