AN ORDINANCE AMENDING THE (INTERGOVERNMENTAL GRANT FUND) BUDGET, DEPARTMENT OF POLICE, TO ANTICIPATE AND APPROPRIATE GRANT AND MATCHING FUNDS IN THE AMOUNT OF \$107,492.42 FOR A GRANT IN THE AMOUNT OF \$53,746.21 FROM THE U. S. DEPARTMENT OF JUSTICE BULLETPROOF VEST PARTNERSHIP TO PURCHASE BODY ARMOR FOR ATLANTA POLICE OFFICERS, AND FOR OTHER PURPOSES

WHEREAS, the Bulletproof Vest Partnership, a program administered by the U. S. Department of Justice has awarded the Atlanta Police Department \$53,746.21, to be matched with local funds totaling \$53,746.21, for a program total of \$107,492.42 to purchase body armor for Atlanta Police Officers, and

WHEREAS, the Atlanta Police Department will use these grant and matching funds to purchase state of the art body armor to assure officer safety in the field, and

WHEREAS, the Budget Commission of the City of Atlanta, Georgia has recommended increasing anticipations and appropriations in the Intergovernmental Grant Fund by \$107,492.42 in response to this grant award

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA

Section One: that the (Intergovernmental Grant Fund) Budget, Department of Police be and is hereby amended as follows:
