AN ORDINANCE TO AMEND CHAPTER 10, ARTICLE 2, SECTION 10-88(E) OF THE CITY OF ATLANTA CODE OF ORDINANCES SO AS TO PROVIDE THAT RESTAURANTS WHICH SELL ALCOHOLIC BEVERAGES FOR ON PREMISES CONSUMPTION AND WHICH ARE LOCATED WITHIN 600 FEET OF A COLLEGE CAMPUS ARE AUTHORIZED TO PROVIDE ENTERTAINMENT AT SUCH RESTAURANTS; AND FOR OTHER PURPOSES.

WHEREAS, the Alcohol Code needs to be changed, so that live music can be allowed at restaurants near a college campus,

BE IT THERFORE ORDAINED, that Article 2, Section 10-88(E) be changed to allow music at restaurants within 600 feet of a college campus.


