Section 1: That a certificate under the provisions of the Metropolitan River Protection Act for land disturbance of 1,062,306 Sq. Ft. and impervious surface of 735,859 Sq. Ft. to enable the construction of three (3) CSO shafts at 2440 Bolton Road, N.W., on property of 13 acres in Land Lot 231, 17th District, Fulton County, Georgia is hereby granted conditional upon the site plan entitled, "R.M. Clayton Overflow MRPA Compliance Plan" by JDH, a Joint Venture, dated January 2, 2004, and stamped received by the City of Atlanta's Bureau of Planning June 4, 2004.

Section 2: That all ordinances or parts of ordinances in conflict with the terms of this ordinance are hereby waived.
