AN AMENDED ORDINANCE

BY FINANCE/EXECUTIVE COMMITTEE

AN ORDINANCE TO AMEND SECTIONS 2-239 AND 2-243
OF THE CODE OF ORDINANCES TO REDEFINE THE
BUREAU OF HOUSING AND CODE COMPLIANCE; AND
FOR OTHER PURPOSES.

NOW THEREFORE THE COUNCIL OF THE CITY OF ATLANTA HEREBY
ORDAINS AS FOLLOWS:

Section 1: Section 2-239 (4), which currently reads as follows:

(4) Bureau of Housing and Code Compliance.

Is hereby deleted in its entirety and replaced by new sections (4) and
(5), to read as follows:

- (4) Bureau of Housing
- (5) Bureau of Code Compliance

Section 2: Section 2-243 is hereby deleted in its entirety and replaced by new code
sections 2-243 and 2-243.1 as follows:

Sec. 2-243 Functions and duties of Bureau of Housing

The functions and duties of the Bureau of Housing shall include:

- (1) Assistance in financing city-initiated housing and development programs;
- (2) Provision of assistance to builders and developers in various aspects of housing construction, rehabilitation and financing in the city;
- (3) Administration, implementation and execution of housing redevelopment, renewal and conservation programs;
- (4) Initiation and operation of programs to improve aesthetics conditions within the city, including elimination of unsightly conditions that affect the urban environment; and
- (5) Provision of relocation assistance to displaced persons and provision of community services and property management in conjunction with the programs and projects for which these services are required.

Sec. 2-243.1 Functions and duties of Bureau of Code Compliance

The functions and duties of the Bureau of Code Compliance shall include:

- (1) Housing and code enforcement;
- (2) Commercial code inspection; and
- (3) Regulation of housing demolition and in rem activities.



Section 3: That all ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.


