**AN ORDINANCE TO WAIVE SECTION 150-207(a)  
OF THE CODE OF ORDINANCES OF THE CITY OF  
ATLANTA TO ALLOW ROLLER SKATING IN THE  
STREETS OF ATLANTA ON OCTOBER 24, 2004  
FOR THE 23<sup>RD</sup> ANNUAL ATHENS TO ATLANTA  
ROAD SKATE; AND FOR OTHER PURPOSES.**

**WHEREAS**, the 23<sup>rd</sup> Annual Athens to Atlanta Road Skate is gearing up for its annual event in the city of Atlanta; and

**WHEREAS**, the City of Atlanta Code of Ordinances does not allow roller skating on its streets; and

**WHEREAS**, the organizers have applied for a festival permit and the waiver of the Code of Ordinances is necessary for the issuance of the permit; and

**WHEREAS**, the organizers will be responsible for obtaining the necessary surety bonds and insurance for liability, will enter into a hold harmless agreement to indemnify the city as well as comply with traffic, sanitation, public safety concerns and will reimburse the City of Atlanta for cost incurred in connection with the 23<sup>rd</sup> Annual Athens to Atlanta Road Skate to be held on Sunday, October 24, 2004 starting at 7:30 a.m. in downtown Athens, Georgia and ending at 5:00 p.m. in Piedmont Park in Atlanta, Georgia.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA**, as follows:

**SECTION 1:** That Section 150-207(a) be waived to allow the Athens to Atlanta Road Skate to use the streets of Atlanta for their expressed purpose.

**SECTION 2:** That all other provisions of Section 150-207 of the Code of Ordinances shall remain in full force and effect.

**SECTION 3:** That all ordinances and parts of ordinances in conflict herewith be and the same are hereby waived.
