AN ORDINANCE APPROPRIATING THE AMOUNT OF \$7,000.00 FOR THE PURPOSE OF PROVIDING SERVICE GRANTS OF \$3,500.00 EACH TO THE ATLANTA PEACH CARNIVAL, INC. AND THE SOUTHERN LATINO FOUNDATION, INC. ; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta Advisory Committee on International Relations approved on June 23, 2004, the following service grant proposals for funding:
