AN ORDINANCE CORRECTING ERRORS TO ADOPTED LEGISLATION 04-0-0371, ADOPTED BY THE CITY COUNCIL ON APRIL 19, 2004 AND APPROVED BY THE MAYOR ON APRIL 27, 2004 AND RESOLUTION 04-R-1289 APPROVED BY CITY COUNCIL ON JULY 19, 2004 AND APPROVED BY THE MAYOR ON JULY 22, 2004; AND FOR OTHER PURPOSES.

WHEREAS, Ordinance 04-0-0371 was adopted by the City Council on April 19, 2004 and approved by the Mayor on April 27, 2004 established fund accounts and cost centers a grant project funded by the Atlanta Regional Commission; and

WHEREAS, Resolution 04-R-1289 was adopted by the City Council on July 19, 2004 and approved by the Mayor on July 22, 2004 authorized a contract agreement under the ARC grant funded project utilizing the wrong cost center; and

WHEREAS, these legislations were adopted and approved with errors in cost centers, and other errors; and

WHEREAS, the errors in these legislations need to be corrected.
