**AN ORDINANCE TO AMEND SECTIONS 2-222, 2-261, AND 2-265 OF THE CODE OF ORDINANCES TO REDEFINE BUREAUS IN THE DEPARTMENT OF PUBLIC WORKS; AND FOR OTHER PURPOSES.**

**WHEREAS**, Section 3-302 of the Charter of the City of Atlanta [1966 Ga. L. (Act No.1019) p. 4469] provides for reorganization of the Executive Branch by Ordinance upon the recommendation of the Mayor, with approval by Council; and

**WHEREAS**, the Mayor has determined that it is in the best interest of the City that certain changes be made to the organization of the Executive branch.

**NOW THEREFORE THE COUNCIL OF THE CITY OF ATLANTA HEREBY ORDAINS AS FOLLOWS:**

**Section 1:** Section 2-222 (12), which currently reads as follows:

“(12) Department of public works, to be headed by a commissioner of public works; said department to be composed of the following bureaus:

- a. Bureau of highways and streets;
- b. Bureau of solid waste services; and
- c. Bureau of traffic and transportation.”

Is hereby deleted and replaced with the following new section 2-222 (12):

“(12) Department of public works, to be headed by a commissioner of public works; said department to be composed of the following bureaus *and office*:

- a. Office of Transportation; and
- b. Office of Solid Waste Services

**Section 2:** Section 2-261, which currently reads as follows:

“Sec. 2-261. Bureaus in the department of public works

The department of public works shall be composed of the following bureaus:



- (1) Bureau of highways and streets:
- (2) Bureau of solid waste services; and
- (3) Bureau of traffic and transportation."

Is hereby deleted in its entirety and replaced with the new section 2-261 as follows:

"Sec. 2-261. Offices in the department of public works

The department of public works shall be composed of the following offices:

- (1) Office of Transportation; and
- (2) Office of Solid Waste Services

**Section 3:** Section 2-265 is hereby amended to delete the phrase "traffic and" as follows:

"Sec. 2-265. Functions and duties of the bureau of ~~traffic and~~ transportation

The functions and duties of the bureau of ~~traffic and~~ transportation shall include:"
