

**AN ORDINANCE BY NATALYN ARCHIBONG  
AS SUBSTITUTED BY FULL COUNCIL**

**ORDINANCE TRANSFERRING APPROPRIATIONS IN THE AMOUNT OF  
\$35,000.00 FOR THE PURPOSE OF FUNDING CD-765, EAST ATLANTA  
BUSINESS AND COMMUNITY PARTNERSHIP; AND FOR OTHER PURPOSES**

**WHEREAS**, the City Council adopted and the Mayor on July 7, 2003 and July 12, 2003, respectively, Resolution 03-R-0977 which approved allocations for various Community Housing Development Organizations (CHDO) under the HOME CHDO Operating Grants; and

**WHEREAS**, SouthStar Community Development Corporation was awarded \$35,000.00 as a CHDO, but SouthStar does not have the necessary housing experience to be designated a CHDO; and

**WHEREAS**, the City desires to honor its funding commitment to SouthStar and fund its East Atlanta Business and Community Partnership project with CDBG funds from project closeouts; and

**WHEREAS**, the mission of the East Atlanta Business and Community Partnership is to implement the East Atlanta Village and Moreland Corridor Studies by providing technical assistance for the development of the East Atlanta Village commercial district; and

**WHEREAS**, various CDBG administrative accounts have small balances and these funds should be closed out and reprogrammed; and

**WHEREAS**, the City has obtained release of funds from the U.S. Department of Housing and Urban Development (HUD) for this project, based on the filing of an environmental clearance.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:**

**Section 1:** That the Twentieth-Eighth Year CDBG Program be and is amended hereby as follows:

- a. In program element Economic Enhancement/Development by adding the project "East Atlanta Business and Community Partnership" and the amount "\$35,000.00"
- b. In program element Program Administration by deleting the amount "\$1,264,950.00" and inserting in lieu thereof the amount "\$1,229,950.00"

**Section 2:** That the 2003 (Community Development Fund) Budget be and is amended hereby as follows:
